We are writing to request your kind consideration for the waiver of the penalty imposed upon us for the delay in the disclosure of financial results under Regulation 33 of 'the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 by the way of notice received to us by email dated March 12, 2024.

Background:

Due to unforeseen technical issues, there was a delay in submitting the required financial results within the prescribed timelines as mandated under Regulation 33 of the SEBI (LODR) Regulations. We acknowledge that the disclosure was not made within the specified timeline, and we deeply regret the oversight.

Steps Taken:

We have sincerely taken corrective measures to ensure the compliance as per Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The required disclosure has now been made and is available on the exchange (NSE platform). Further we have instituted internal controls to further enhance the timeliness of future submissions.

Request for Waiver:

In light of the circumstances outlined above, we humbly request **National Stock Exchange** (NSE) to consider our application for a waiver of the penalty imposed for this delay. The delay was unintentional and stemmed from technical glitch resulting in delay for preparation & disclosing the Financial Result, and we have taken proactive steps to prevent such occurrences in the future.

We assure NSE that we remain committed to adhering to all regulatory requirements and the spirit of transparency and governance as laid out by SEBI.

We kindly request you to consider our case sympathetically and waive the penalty. We would be happy to provide any additional information or clarification if needed.
