Pursuant to regulations 30 read with clause 14 para A part A of Schedule III of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), this is to inform you that the Board of Directors of Supreme Facility Management Limited ('SFML' or 'the Company') at its meeting held on January 07, 2025 have, inter-alia considered to approved the alteration in Clause III (A): the Main Object Clause of Memorandum of Association ('MOA') of the Company by inserting clause 3 after clause 2 of Clause III (A), subject to approval of Members by the way of Postal Ballot.
